MAILBOX INFORMATION

From time to time homeowners have had issues with their mailbox locks. Homeowners are responsible for their keys and locks. Whenever a lock freezes or no longer will work, it is suggested to spray WD-40 on the lock.

If you lose your key or the key will no longer work in the lock, you can call the Roanoke Post Office and they will replace the lock with a new key for \$40.

The association does not have a list of the addresses and which box belongs to which address. The association does not have extra keys for the mailboxes.
